

OMRA MEMBERSHIP APPLICATION

Any guest may attend an Association function and look over the displays and operations to determine if they are interested in joining. They may be offered the use of Association or another members equipment to see how to operate the layout. These visits are to be encouraged.

- A. A guest may attend up to 3 operating sessions to determine interest in the Association and potential compatibility. At the end of 3 sessions, or sooner if desired, the guest may ask to become a member of the Association. He/she fills out application and pays the appropriate dues. This application will be presented to the Association during a scheduled business meeting, with the applicant present. The members present will then vote on accepting the applicant as a new member. If the applicant is rejected, the dues will be returned. The Association may do a background check.
- B. Family members as defined in the By-laws have the same usage rights as a full member. These rights do not include voting or election as a Association officer. Children must be accompanied by and actively supervised at all times by a family member.
- C. Family members aged 18 years old may apply for a full membership. They must have written approval from a parent or legal guardian. This adult must attend a business meeting to give permission for the young adult to join. The young adult will undergo a 90 day probationary period. During this period, no dues are due. The young adult member must be accompanied by and actively supervised at all times by an adult member. Arrangements must be made prior to using the Association layout for a volunteer full member to sponsor the young adult. If no one volunteers, the young adult will not be allowed to use the facilities at that time.
- D. Membership is open to any person who has an interest in Model Railroading or other related interests found congenial by Association members. Dues are set in the Standing Rules of the Association. The membership shall consist of those whose dues are paid up. Only dues paying full members in good standing have the right to vote.
- E. Types of membership
 - 1. Full Member: A Full Member is any adult paying dues. Dues are \$240 annually and may be paid \$60 quarterly
 - 2. Family member: A Family Member is any spouse and or child of a "Full Member". In the case of children of "Full Members" they will remain a "Family Member", regardless of age, as long as they still live at home with the "Full Member. Family members upon reaching age of 18 may apply for full membership if desired.
 - 3. Honorary Member: Person who has been granted honorary membership for reasons deemed appropriate by a vote of the Association membership. This is a non-voting membership.
 - 4. Non-Resident Member: A person whose primary place of residence is more than 75 miles from the principal place of business of the Association. Dues are \$60, payable annually.
- F. Voting Rights
 - 1. Full Members are eligible to vote on all matters brought before the membership for a vote, as long as their dues are not in arrears.
 - 2. Full Members are allowed to vote by signed absentee ballot on any decision or election, provided that the ballot is delivered to the presiding officer before the vote is taken. Proxy voting is not allowed. Voting privileges may be granted to an adult Family Member on a case by case decision by the executive committee.

3. Membership status may be suspended if dues fall 2 months in arrears, and may be revoked if dues fall 3 months in arrears.

Exceptions to 3. above may be granted by a majority vote of the Association Members present at a regular membership meeting. Request for exception should be submitted to Executive Committee in writing, stating reason for delinquency, expected duration, and steps Member is taking. Executive Committee will either approve and bring to vote at regular meeting, or reject if they feel need is not justified.

4. Resignations should be submitted in writing to a member of Executive Committee. No reimbursement for partial dues will be given. Members in suspended status will be placed on the inactive membership list until dues are made current.

Severability: The undersigned expressly agree that the foregoing assumption of risk, release and waiver of liability and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Oklahoma, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
